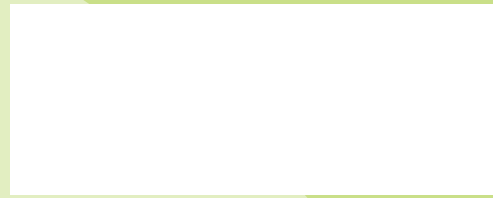

The practising licence year starts on 1st July to 30 June of the following year.
