


Presiding Member's Report

This is the nineteenth annual report for the Electrical Workers Registration Board.

During the year, Penny Mudford stepped down from the Board after serving two terms and Tony Ahern retired from the Board during his first term. The vacancy created by Penny's departure was filled by Debra Hall. Debra brings to the Board a wide range of skills that have added to the Board's ability to show leadership in its decision making. The vacancy created by Tony's retirement has been carried by the Board since his departure in February. The position has been advertised and the Board is looking forward to a replacement being appointed shortly. It was my pleasure having served with them both and I wish to thank them for their valuable input.

During the year the Board has used sub-committees to spread the workload of Board members to support the required changes that are taking place on the Board and within the industry. The review of all the Board's policies is under way. A new website to help better communicate with industry and the public was released, assisting the Board to ensure electrical workers value their licence and that the public and employers are aware of the advantages of employing licensed electrical workers. The other area that the Board has reviewed is the auditing of registered electrical workers in the industry. The main direction of this review has been to ensure the audit of a wide selection of registered practitioners.

The Board over the last year met with practitioners at some of its meeting venues, to obtain feedback and also help practitioners understand the changes that the industry is making. These meetings had a varying degree of success as to the numbers attending. The Board is looking at ways that it can achieve better numbers at these meetings.

The number of registered practitioners over all classes of registration increased by 1,603 in the last year. The Board considered 64 investigators' reports in the 2013/ 2014 year. Of those reports, 44 complaints were heard by the Board, resulting in 39 practitioners being found guilty of disciplinary offences under the Electricity Act 1992. The Board also considered 45 reports relating to non-registered people, with 14 of those people found guilty at prosecution. A number of other such cases are currently before the courts, with the number of prosecutions taken up on the 2012/2013 year.

Since the establishment of the Ministry of Business, Innovation and Employment (Ministry), the Board and the Ministry have held meetings to discuss and agree on ways that the Ministry will continue to support the Board in its functions. Two key areas of discussion are the working towards a new Schedule of Delegations and a Service Level Agreement. The Board is committed, as is the Ministry, to making sure that the Board can carry out its functions in the most efficient and effective manner, to ensure that electrical workers are competent and operate within a regulatory environment to make certain the public are protected and safe. I would like to acknowledge the input and the assistance from the Ministry staff involved in making the transition as seamless as possible.

The Board has taken every opportunity to consult with the industry when there are changes required to enable the Board to carry out its functions. The Board appreciates the contributions and objective opinions that are sent to the Board.

It has been my privilege to have been the Presiding Member of the Electrical Worker Registration Board. I could not have carried out this role without the support of Shane Dolan the Deputy Presiding member, and the other members of the Board. Their commitment to ensure that the industry has strong fundamentals when it comes to competency of registered electrical workers, to ensure their safety as well as that of the public, is valued. The Board wishes to thank the Registrar, John Sickels, for his continued support and service to the Board, and acknowledge all other staff within the Ministry that support the Board in carrying out its role and functions.

Output Agreement

The Minister for Building and Construction has an Output Agreement with the Board which establishes performance and service delivery measures.

The Agreement enables the Minister to monitor the Board, and hold the Board responsible for its performance. The Agreement is split into two sections being governance and service delivery.

Governance

During the year the Board reviewed and reaffirmed its delegations to the Registrar. The delegations ensure the effective and efficient operations of the Board with the Registrar providing the Board with an operational report on a monthly basis. A Board self review along with an induction programme were carried out during the year. The Board's conflict of interest register was maintained and updated.

The Board

The Board met twelve times over thirty five days during the year.

In October the Minister for Building and Construction appointed Debra Hall to the Board and the Presiding Member Penny Mudford completed her term. Tony Ahern resigned from the Board in February.

At the November meeting the Board elected Neil McLeod and Shane Dolan to the respective positions of Presiding and Deputy Presiding Members and the positions were reaffirmed at the first meting of the calendar year in February.

The Board has established three Committees being Policy, Audit and Communications. The Committees meet with industry Stakeholders as and when required.

Electricity (Safety) Regulations 2010

As referenced in the Board's previous report, the Board participated in, and provided comment on amendments to the regulations which came into force in July.

Certification

To ensure a smooth transition into the new certification scheme required by the regulations the Board made hard copy certification forms available to the industry free of charge and that initiative has been well received by the industry. As the initiative has costs associated with it the Board will carry out a review in the forthcoming year to determine whether or not the initiative should continue.

Irrespective of the outcome of the Board's review the Board will continue to make the "form of the form" available online and the form will be free to download. As an added dimension free electronic filing of completed certificates will also continue to be available.

Information dissemination

During the year a new user friendly website was commissioned to replace the previous site that dated back to the 1990s. The new site has been designed so that it will be easier for electrical workers and consumers to quickly find information.

The Board's ELECTRON newsletter was issued five times to in excess of 49,000 people and it along with all Board discussion papers are available to view on line at ewrb.govt.nz

The Board held "meet the people" meetings in Whangarei, Rotorua and Wellington to obtain feedback from industry on activities being carried out by the Board and a client survey was also undertaken.

Industry Partners

The Board met with representatives of the Electrical Contractors Association of New Zealand, Electricity Engineers Association, WorkSafe New Zealand and the Skills Industry Training Organisation. The Board also held meetings with the Ministry of Business Innovation and Employment.

In addition the Board has been represented at meetings of the Australasian Electricity Regulators Advisory Council, New Zealand Electrical Institute and the Infrastructure Industry Training Organisation.

The Board has continued with its Memoranda of Understanding with;

- The Skills Organisation
- The Infrastructure Industry Training Organisation
- The Electrical Contractors Association
- The Electrical Technical Association Inc; and
- Site Safe

The previously reported on contract with Standards New Zealand continues and the arrangement provides for the holders of Board practising licences and limited certificates to log on to the Standards New Zealand data base to view, download and print the latest versions of electronic standards files.

Review of classes of registration, requirements/standards for registration and associated limits of work

As considerable work was being undertaken by the Industry Training Organisations on qualification reviews during the year the Board postponed the release of its third discussion paper on the review of classes of registration, requirements/standards for registration and associated limits of work.

The Board and the Industry Training Organisations have worked closely on aspects of the reviews and, as that work has now been well advanced the Board anticipates releasing the discussion paper early in the forthcoming year.

The Board continued its programme of reviewing, developing and implementing policies and as a result policies have been introduced for the following aspects;

Audit Framework for Determining Worker Competency

The Board has progressed its review of the audit frameworks for determining worker competency by releasing a discussion paper for comment. Feedback on the proposals contained in the paper has been valuable and the Board expects to make draft decisions on the audit framework in the latter part of the forthcoming year.

Comments on Statistics

Complaints and Investigations

During the year the Registrar received 64 complaints which were lodged against registered and registered/ licensed people. That figure was down by 23 on the previous year's figure of 87.

The Board considered 64 Investigator complaint reports during the year and of that number Investigators determined no further action be taken in relation to 21 of the complaints. The Board held hearings for 44 complaints and 39 people were found guilty of disciplinary offences.

The Board considered 45 reports relating to people undertaking unauthorised work in contravention of the Electricity Act 1992. 14 of those people were found guilty of offences in the District Court and a number of cases are currently before the Court.

Registrations and Practising Licences

The number of new registrations issued increased by 240 over the previous year's figure to a total of 1,603.

The 2013/2014 year was the first year of the Board's two year practising licence programme and a total of 11,216 licences were issued for the year. A total of 26,000 practising licences will expire on 30 June 2015.

Examinations

As stated earlier in this report a total of 3,250 candidates attempted Board examinations during the year and an overall pass rate of 61% was achieved.

The number of candidates attempting examinations was down 70 on last year's figures and this is the second year where such numbers have decreased.

The Board has noted the trend in the numbers of people attempting examinations and will be drawing the industry's attention to the situation as the Board is concerned that if the trend continues there may not be enough registered/licensed people available to satisfy future work volume demands.





THREE-YEAR TREND OF COMPLAINTS





NUMBER OF NEW REGISTRATIONS JULY 2013 – JUNE 2014






NUMBER OF NEW PRACTICE LICENCES JULY 2013 – JUNE 2014




Michael Macklin


