Role and functions of the Board

The Electrical Workers Registration Board (the Board) was established under section 148 of the Electricity Act 1992 (the Act). The Board's main functions are set out in section 149 of the Act. The Board currently has seven members, five of whom are registered electrical workers. All members are appointed by the Minister for Building and Construction.

The Board's primary functions are to register and license electrical workers and to ensure their competency to promote public safety. It does this by ensuring a minimum standard of competence for issuing and retaining a licence, holding disciplinary hearings about complaints, prosecuting individuals who carry out unauthorised prescribed electrical work (PEW), and undertaking other activities that support safe and compliant PEW.

The Occupational Regulation team within the Market Integrity branch of the Ministry of Business, Innovation and Employment (the Ministry) provides, among other things, operational support for registering and licensing electrical workers on behalf of the Registrar. The Registrar acts under delegation from the Board.

2024/2025 Presiding Member's Report

Tēnā koutou

I am pleased to share this annual report update.

This year, we welcomed Lucy Wright, Truc Tran, and Simon Rogers to the Electrical Workers Registration Board (EWRB). Their appointments enhance the Board's ability to meet its statutory responsibilities and reflect our ongoing commitment to diverse, skilled, and informed governance.

We farewelled Mel Orange, whose long-standing contribution to the Board has been greatly appreciated. We thank Mel sincerely for his dedication and leadership.

The Board also welcomed Briana Rae to our Future Board Member programme. This initiative gives aspiring electrical workers insight into Board operations and governance. Participants receive training, attend selected meetings, and are mentored by a current Board member. While Future Members do not hold voting rights, they are encouraged to contribute to discussions during their one-year term.

As part of our annual strategic review, the Board engaged with key stakeholders to help shape our priorities and initiatives. These conversations continue to inform our direction and reinforce our commitment to improving processes and effectiveness.

Over the past year, the Board managed a range of complaints and disciplinary matters with diligence and fairness. Our processes remain robust, transparent, and guided by principles of natural justice. We held 52 disciplinary hearings into the conduct of registered electrical workers, resulting in 38 disciplinary outcomes. The Board continues to see cases where electrical workers submit false or misleading certification documents or fail to renew their practising licences on time resulting in unlicensed work and disciplinary breaches.

We are pleased to resume our "Meet and Greet" schedule in 2025. These events give electrical workers a chance to engage directly with the Board, receive updates and ask questions. Feedback has been positive and will continue to shape our engagement approach.

We've made significant progress in implementing new registration and licensing requirements to improve clarity and safety within the Electrical Worker Scheme. Key developments include new endorsed classes, updated competency pathways, and the rollout of digital licences with real-time verification. Grandparenting arrangements have supported a smooth transition, and further updates to registration class limits are expected in the second half of 2025.

Finally, I'd like to thank my fellow Board members, the Registrar, and Ministry staff for their ongoing efforts and contributions throughout the year.

Industry Engagement

- The Board resumed its meet and greet schedule in 2025, holding events in Auckland, Dunedin, and Wellington.
 These sessions provided valuable opportunities for electrical workers to engage directly with the Board, hear updates, and ask questions.
- The Electron newsletter was published throughout the 2024/2025 year, providing regular updates and key information to electrical workers.
- The Board regularly engaged with industry associations to provide updates on the implementation of the new Stepped Licensing registration framework.
- The Board continued to engage with Waihanga Ara Rau to ensure New Zealand qualifications met registration requirements.
- The Board engaged with key stakeholders as part of its annual strategic review and key strategic initiatives.

Strategic Projects

STEPPED LICENSING - UPDATE

Significant progress was made on implementing new registration and licensing requirements to improve clarity and safety of the Electrical Worker Scheme. This follows the publication of two Notices in 2023 that introduced:

- new endorsed classes of registration for electrical workers supervising more than two people carrying out PEW, and for electrical workers working in higher-risk work areas
- changes to registration and competency programme requirements
- new for career progression pathways.

Grandparenting arrangements helped experienced electrical workers transition smoothly to the new endorsed registration classes, with around 2,800 applications received.

The Ministry worked with Waihanga Ara Rau to recommend core competencies that electrical workers must demonstrate to meet the endorsed supervision registration requirements.

After considering industry advice, the Board commenced work updating the Notice that sets out registration class work limits and requirements. This work is expected to be completed in the second half of 2025.

All electrical workers upgraded to real time digital licences that they can download from the Electrical Workers portal at any time. Each licence includes a QR code to the electrical worker's profile on the public register.
