#### Procedure:

The matter was considered by the Electrical Workers Registration Board (the Board) under the provisions of Part 11 of the Electricity Act 1992 (the Act), the Electricity (Safety) Regulations 2010 (the Regulations) and the Board's Disciplinary Hearing Rules.

#### Board Decision:

The Respondent **has** committed disciplinary offences under sections 143(b)(ii), 143(d) and 143(f) of the Act.

## Introduction

- [1] The hearing resulted from a complaint about the conduct of the Respondent and a report under section 147G(1) of the Act from the Investigator that the complaint should be considered by the Board.
- [2] The Respondent was served with a notice setting out the alleged disciplinary offences the Investigator reported should be considered by the Board. They were:

### First Alleged Disciplinary Offence

1. During January and February 2019 at [REDACTED] [REDACTED] Mr Viliami Unga has carried out or caused to be carried out prescribed electrical work in a manner contrary to any enactment relating to prescribed electrical work that was in force at the time the work was done being an offence under section 143(a)(ii) of the Act, IN THAT, he:
  - (a) has carried out prescribed electrical work outside the limits of his registration being the replacement of a switchboard; and/or
  - (b) has failed to provide the additional protection of RCD’s (residual current devices) in breach of Section 84 of the Electricity Act 1992 and NZ gazette No 2019-no1762 and in breach of regulations 5 and 13 and 20(1)(c) and 59 of the Electricity (Safety) Regulations 2010.

Or in the Alternative

2. During January and February 2019 at [REDACTED]  
[REDACTED] Mr Viliami Unga has carried out or caused to be carried out prescribed electrical work in a negligent or incompetent manner being an offence under section 143(a)(i) of the Act, IN THAT, he:
  - (a) has carried out prescribed electrical work outside the limits of his registration being the replacement of a switchboard; and/or
  - (b) has failed to provide the additional protection of RCD's.

Or in the Alternative

3. During January and February 2019 at [REDACTED]  
[REDACTED], Mr Viliami Unga has negligently created a risk of serious harm to any person, or a risk of significant property damage, through having carried out or caused to be carried out prescribed electrical work being an offence under section 143(b)(ii) of the Act, IN THAT, he:
  - (a) has carried out prescribed electrical work outside the limits of his registration being the replacement of a switchboard; and/or
  - (b) has failed to provide the additional protection of RCD's.

#### Second Alleged Disciplinary Offence

4. During January and February 2019 at [REDACTED]  
[REDACTED], Mr Viliami Unga has done prescribed electrical work that, under the terms of any restriction or limitation that applies to the prescribed electrical work that the person may do, the person is not authorised to do being an offence under section 143(d) of the Act, IN THAT, he installed a switchboard being prescribed electrical work that is deemed to be outside the limits of his registration.

#### Third Alleged Disciplinary Offence

5. During January and February 2019 at [REDACTED]  
[REDACTED], Mr Viliami Unga has failed to provide a return being an offence under section 143(f) of the Act, IN THAT, he failed to provide an electrical safety certificate for the installation of replacement light fittings, power sockets and light switches.

- [3] Prior to the hearing, the Respondent and the Board were provided with all of the documents the Investigator had in his/her power or possession.
- [4] No Board Members declared any conflicts of interest in relation to the matters under consideration.

### Function of Disciplinary Action

[5] The common understanding of the purpose of professional discipline is to uphold the integrity of the profession. The focus is not punishment, but the protection of the public, the maintenance of public confidence and the enforcement of high standards of propriety and professional conduct. Those purposes were recently reiterated by the Supreme Court of the United Kingdom in *R v Institute of Chartered Accountants in England and Wales*<sup>1</sup> and in New Zealand in *Dentice v Valuers Registration Board*<sup>2</sup>.

[6] Disciplinary action under the Act is not designed to redress issues or disputes between a complainant and a respondent. In *McLanahan and Tan v The New Zealand Registered Architects Board*<sup>3</sup> Collins J. noted that:

*“... the disciplinary process does not exist to appease those who are dissatisfied ... . The disciplinary process ... exists to ensure professional standards are maintained in order to protect clients, the profession and the broader community.”*

[7] The Board can only inquire into “the conduct of an electrical worker” with respect to the grounds for discipline set out in section 143 of the Act. It does not have any jurisdiction over contractual matters.

### Procedure

[8] The matter proceeded on the basis of an Agreed Statement of Facts. The Respondent and Counsel for the Investigator appeared.

### Evidence

[9] The Board must be satisfied on the balance of probabilities that the disciplinary offences alleged have been committed<sup>4</sup>. The Board notes, as regards evidence in proceedings before it, that the provisions of section 147W of the Act apply. This section states:

*In all proceedings under this Part, the Board may, subject to section 156, receive as evidence any statement, document, information, or matter that may in its opinion assist it to deal effectively with the matter before it, whether or not it would be admissible as evidence in a court of law.*

[10] The matter proceeded on the basis of an Agreed Statement of Facts. The Statement set out that the Respondent, an Electrical Service Technician (EST) undertook the replacement of light fittings, power sockets and light switches. He did not provide an Electrical Safety Certificate (ESC) for the work. He also carried out the replacement of a switchboard during the same period. He did not provide the required additional protection of RCD’s on the switchboard that he installed. The switchboard was outside of the limits of his registration as an EST.

- [11] The Investigator engaged Mr Doust, an Electrical Inspector, to provide a technical review and report. He reviewed the photograph evidence supplied and confirmed the allegations. The Respondent acknowledged that he replaced the switchboard and that Mr Doust's findings were correct. The Respondent stated he "believed the work he carried out had helped the family rather than put them in danger". He was requested by the property owner if there was something he could do about the switchboard. He did charge for the work carried out. The Respondent stated:

*... the board consisted of old fuse panel and exposed wires, this was a high risk situation for fire or could possibly electrocute someone. I then decided to reduce the risk, I replaced the board for him as agreed by him. I did this with high standard and accordingly to what I have been trained.*

- [12] The Respondent accepted he had negligently created a risk of serious harm to any person, or a risk of significant property damage and that he had carried out prescribed electrical work that he was not authorised to do. The Respondent also accepted that he had provided a false or misleading return.
- [13] The general rule is that all facts in issue or relevant to the issue in a case must be proved by evidence. As the Investigator and Respondent agreed to the facts as outlined above it was not necessary to call any further evidence or to test the evidence as outlined in the Agreed Statement of Facts.

#### **Board's Conclusion and Reasoning**

- [14] The Board has decided that the Respondent **has** negligently created a risk of serious harm to any person, or a risk of significant property damage, through having carried out or caused to be carried out prescribed electrical work being an offence under section 143(b)(ii) of the Act, in that, he carried out prescribed electrical work outside the limits of his registration being the replacement of a switchboard and failed to provide the additional protection of a residual current device (RCD).
- [15] The Board has also decided that the Respondent **has** done prescribed electrical work that, under the terms of any restriction or limitation that applies to the prescribed electrical work that the person may do, the person is not authorised to do being an offence under section 143(d) of the Act, in that, he installed a switchboard being prescribed electrical work that is deemed to be outside the limits of his registration.
- [16] The Board has further decided that the Respondent **has** failed to provide a return being an offence under section 143(f) of the Act, in that, he failed to provide an Electrical Safety Certificate for the installation of replacement light fittings, power sockets and light switches.
- [17] The Board made its decisions based on the Agreed Statement of Facts, the Respondent's acceptance of responsibility and on the basis of the following reasoning.

## First Offence

[18] The First Alleged Offence was laid in the alternatives of negligently creating a risk of serious harm or significant property damage, carrying out or causing to be carried out in a negligent or incompetent manner or in a manner contrary to an enactment.

[19] To make a finding on the First Alternative, the Board must make a finding that there was a risk of serious harm or significant property damage. Serious harm is defined in section 2 of the Act. It means:

*death; or  
injury that consists of or includes loss of consciousness; or  
a notifiable injury or illness as defined in section 23 of the Health and Safety at Work Act 2015.*

[20] The relevant parts of Section 23 of the Health and Safety at Work Act 2015 are:

### **23 Meaning of notifiable injury or illness**

(1) *In this Act, unless the context otherwise requires, a notifiable injury or illness, in relation to a person, means—*

(a) *any of the following injuries or illnesses that require the person to have immediate treatment (other than first aid):*

(i) *the amputation of any part of his or her body:*

(ii) *a serious head injury:*

(iii) *a serious eye injury:*

(iv) *a serious burn:*

(v) *the separation of his or her skin from an underlying tissue (such as degloving or scalping):*

(vi) *a spinal injury:*

(vii) *the loss of a bodily function:*

(viii) *serious lacerations:*

(b) *an injury or illness that requires, or would usually require, the person to be admitted to a hospital for immediate treatment:*

(c) *an injury or illness that requires, or would usually require, the person to have medical treatment within 48 hours of exposure to a substance:*

[21] Significant property damage is not defined in the Act. Section 16(1)(b)(ii) of the Act, which relates to notification of accidents, also refers to serious harm and to property damage. In respect of damage it requires notification where there is:

*damage to any place or part of a place that renders that place or that part of that place unusable for any purpose for which it was used or designed to be used before that accident.*

- [22] As section 16 refers to both serious harm and to damage the Board considers significant property damage in section 143(b)(ii) should be interpreted in line with the definition in section 16(1)(b)(ii).
- [23] Actual serious harm or significant property damage need not occur. There need only be a risk that either might occur. The risk must be real in that there needs to be a material or substantial possibility, chance or likelihood that serious harm or significant property damage will occur. A real risk has also been described as one that a reasonable person would not brush aside as being far-fetched or fanciful<sup>5</sup>.
- [24] The First Alternative also requires that the Respondent be found to have been negligent. Negligence is the departure by an electrical worker, whilst carrying out or supervising prescribed electrical work, from an accepted standard of conduct. It is judged against those of the same class of licence as the person whose conduct is being inquired into. This is described as the *Bolam*<sup>6</sup> test of negligence which has been adopted by the New Zealand Courts<sup>7</sup>.
- [25] The New Zealand Courts have stated that the assessment of negligence in a disciplinary context is a two-stage test<sup>8</sup>. The first is for the Board to consider whether the practitioner has departed from the acceptable standard of conduct of a professional. The second is to consider whether the departure is significant enough to warrant a disciplinary sanction.
- [26] When considering what an acceptable standard is the Board must have reference to the conduct of other competent and responsible practitioners and the Board's own assessment of what is appropriate conduct, bearing in mind the purpose of the Act<sup>9</sup>. The test is an objective one, and in this respect, it has been noted that the purpose of discipline is the protection of the public by the maintenance of professional standards and that this could not be met if, in every case, the Board was required to take into account subjective considerations relating to the practitioner<sup>10</sup>.
- [27] The Board notes that the purposes of the Act are:

**1A Purposes**

*The purposes of this Act are—*

- (a) *to provide for the regulation, supply, and use of electricity in New Zealand; and*
- (b) *Repealed.*
- (c) *to protect the health and safety of members of the public in connection with the supply and use of electricity in New Zealand; and*

- (d) *to promote the prevention of damage to property in connection with the supply and use of electricity in New Zealand; and*
- (da) *to provide for the regulation of fittings and electrical appliances that are, or may be, exported pursuant to an international trade instrument; and*  
*to provide for the regulation of electrical workers.*

[28] The Board also notes, as regards acceptable standards, that all electrical work must comply with the Electricity (Safety) Regulation 2010 and the cited Standards and Codes of Practice in Schedule 2 of the Regulations. As such, when considering what is and is not an acceptable standard, they must be taken into account.

[29] Turning to seriousness in *Collie v Nursing Council of New Zealand*<sup>11</sup> the Court's noted, as regards the threshold for disciplinary matters, that:

*[21] Negligence or malpractice may or may not be sufficient to constitute professional misconduct and the guide must be standards applicable by competent, ethical and responsible practitioners and there must be behaviour which falls seriously short of that which is to be considered acceptable and not mere inadvertent error, oversight or for that matter carelessness.*

[30] Given the above factors the Board, which includes persons with extensive experience and expertise in carrying out and supervising prescribed electrical work, considered the Respondent has departed from what the Board considers to be an accepted standard of conduct and that the conduct was sufficiently serious enough to warrant a disciplinary outcome.

### Second Offence

[31] The second charge related to the Respondent working outside of the limits of his registration and licence.

[32] Section 84 of the Act allows the Board to designate classes of registration and to specify for each of those classes the prescribed electrical work that a person is authorised to do. The Board does so by way of Gazette Notices. The applicable Gazette Notice<sup>12</sup> specified the limits for a person holding registration as an Electrical Service Technician.

[33] The prescribed electrical work carried out by the Respondent included work that the Respondent was not authorised to carry out. As such, he has worked outside of the limits of his registration and licence.

### Third Offence

[34] The third charge relates to the failure to provide a return. In determining the matter, the intention of the issuer is irrelevant<sup>13</sup>. There is a requirement that an Electrical

Safety Certificate be issued for all prescribed electrical work. One was not issued. The Respondent was not aware of the requirement for it. The offence has been committed.

### **Penalty, Costs and Publication**

- [35] Having found that one or more of the grounds in section 143 applies the Board must, under section 147M of the Act<sup>i</sup>, consider the appropriate disciplinary penalty, whether the Respondent should be ordered to pay any costs and whether the decision should be published.
- [36] The Respondent made submissions at the hearing as regards penalty, costs and publication.

### Penalty

- [37] The purpose of professional discipline is to uphold the integrity of the profession; the focus is not punishment, but the enforcement of a high standard of propriety and professional conduct. The Board does note, however, that the High Court in *Patel v Complaints Assessment Committee*<sup>14</sup> commented on the role of “punishment” in giving penalty orders stating that punitive orders are, at times, necessary to provide a deterrent and to uphold professional standards. The Court noted:

*[28] I therefore propose to proceed on the basis that, although the protection of the public is a very important consideration, nevertheless the issues of punishment and deterrence must also be taken into account in selecting the appropriate penalty to be imposed.*

- [38] The Board also notes that in *Lochhead v Ministry of Business Innovation and Employment*<sup>15</sup> the Court noted that whilst the statutory principles of sentencing set out in the Sentencing Act 2002 do not apply to the Electricity Act they have the advantage of simplicity and transparency. The Court recommended adopting a starting point for a penalty based on the seriousness of the disciplinary offending prior to considering any aggravating and/or mitigating factors. The same applies to disciplinary proceedings under the Electricity Act.
- [39] The offending was serious. The Board was also concerned that the Respondent was not aware of the limits of his registration or of the requirement to provide an Electrical Safety Certificate for all prescribed electrical work.
- [40] The Respondent noted that he intends to obtain a licence as an electrician. Until he does, he needs to be aware of what he is and is not allowed to do. To ensure this, the Board has decided it will order him to undertake training.
- [41] Based on the above, the Board’s penalty decision is that the Respondent is, at his own cost and within six months of this order, to:

- (a) successfully complete and pass the training course for an Electrical Service Technician; and
- (b) pass the Board's Electrical Service Technician regulations exam.

### Costs

- [42] Under section 147N of the Act the Board may require the Respondent to pay the Board any sum that it considers just and reasonable towards the costs and expenses of, and incidental to the investigation, prosecution and the hearing.
- [43] The Respondent should note that the High Court has held that 50% of total reasonable costs should be taken as a starting point in disciplinary proceedings and that the percentage can then be adjusted up or down having regard to the particular circumstances of each case<sup>16</sup>.
- [44] In *Collie v Nursing Council of New Zealand*<sup>17</sup> where the order for costs in the tribunal was 50% of actual costs and expenses the High Court noted that:

*But for an order for costs made against a practitioner, the profession is left to carry the financial burden of the disciplinary proceedings, and as a matter of policy that is not appropriate.*

- [45] Based on the above the Board's costs order is that the Respondent is to pay the sum of \$425 toward the costs of and incidental to the matter. In setting the amount of costs the Board took into account that the Respondent had agreed to the matter proceeding by way of an Agreed Statement of Facts.

### Publication

- [46] As a consequence of its decision, the Respondent's name and the disciplinary outcomes will be recorded in the public register as required by the Act<sup>18</sup>. The Board can, pursuant to section 147Z of the Act, also order publication over and above the public register notation. Under section 147Z the Board may, if no appeal is brought within 20 working days of its decision, direct the Registrar to cause a notice stating the effect of the decision or order, the reasons for the decision or order, and (unless the Board directs otherwise) the name of the person in respect of whom the decision or order was made, to be published in the Gazette and any other publications as may be directed by the Board.
- [47] As a general principle, such further public notification may be required where the Board perceives a need for the public and/or the profession to know of the findings of a disciplinary hearing. This is in addition to the Respondent being named in this decision.

- [48] Within New Zealand there is a principle of open justice and open reporting which is enshrined in the Bill of Rights Act 1990<sup>19</sup>. The Criminal Procedure Act 2011 sets out grounds for suppression within the criminal jurisdiction<sup>20</sup>. Within the disciplinary hearing jurisdiction the courts have stated that the provisions in the Criminal Procedure Act do not apply but can be instructive<sup>21</sup>. The High Court provided guidance as to the types of factors to be taken into consideration in *N v Professional Conduct Committee of Medical Council*<sup>22</sup>.
- [49] The courts have also stated that an adverse finding in a disciplinary case usually requires that the name of the practitioner be published in the public interest<sup>23</sup>. It is, however, common practice in disciplinary proceedings to protect the names of other persons involved as naming them does not assist the public interest.
- [50] Based on the above, the Board will publish a general article in the Electron summarising the matter but will not order further publication. The Respondent will be identified in the Electron.

### **Penalty, Costs and Publication Orders (Reissued pursuant to Section 156A of the Act)**

[51] For the reasons set out above, the Board directs that:

**Penalty:** Pursuant to section 147M(1)(e) of the Electricity Act 1992, the Respondent is ordered, at his own cost and within 6 months of this order, to undertake the following training:

- (a) successfully complete and pass the training course for an Electrical Service Technician; and
- (b) pass the Board's Capstone examination for an Electrical Service Technician.

**Costs:** Pursuant to section 147N of the Act, the Respondent is ordered to pay costs of \$450 (GST included) towards the costs of, and incidental to, the inquiry of the Board.

**Publication:** The Registrar shall record the Board's action in the Register of Electrical Workers in accordance with section 128(1)(c)(viii) of the Act.

**The Respondent will be named in this decision.**

**A summary of the matter will be published by way of an article in the Electron which will focus on the lessons to be learnt from the case. The Respondent will be named in the publication.**

[52] The Respondent should note that the Board may refuse to relicence an electrical worker who has not paid any fine or costs imposed on them.

### **Right of Appeal**

[53] The right to appeal Board decisions is provided for in section 147ZA and 147ZB of the Act<sup>ii</sup>.

(1) *If the Board, after conducting a hearing, is satisfied that a person to whom this Part applies is guilty of a disciplinary offence, the Board may—*

- (a) *do 1 or more of the following things:*
  - (i) *order that the person's registration or practising licence (or both) be cancelled;*
  - (ii) *order that the person's provisional licence be cancelled;*

- 
- (iii) order that the person may not apply to be reregistered or re-licensed before the expiry of a specified period:
  - (b) order that the person's registration or practising licence (or both), or the person's provisional licence, be suspended—
    - (i) for any period that the Board thinks fit; or
    - (ii) until that person does 1 or more of the things specified in subsection (2):
  - (c) order that the person's registration or practising licence (or both), or the person's provisional licence, be restricted for any period that the Board thinks fit, in either or both of the following ways:
    - (i) by limiting the person to the work that the Board may specify;
    - (ii) by limiting the person to doing, or assisting in doing, work in certain circumstances (for example, by limiting the person to work only on approved premises or only in the employ of an approved employer):
  - (d) order that the person be disqualified from doing or assisting in doing prescribed electrical work that the person would otherwise be authorised to do in that person's capacity as a person to whom this Part applies—
    - (i) permanently, or for any period that the Board thinks fit; or
    - (ii) until that person does 1 or more of the things specified in subsection (2):
  - (e) order the person to do 1 or more of the things specified in subsection (2) within the period specified in the order:
  - (f) order the person to pay a fine not exceeding \$10,000:
  - (g) order that the person be censured:
  - (h) make no order under this subsection.
- (2) The things that the person can be required to do for the purposes of subsection (1)(b), (d), and (e) are to—
- (a) pass any specified examination:
  - (b) complete any competence programme or specified period of training:
  - (c) attend any specified course of instruction.
- (3) The Board may take only 1 type of action in subsection (1) in relation to a case, except that it may impose a fine under subsection (1)(f) in addition to taking the action under subsection (1)(b), (c), (e) or (g).
- (4) No fine may be imposed under subsection (1)(f) in relation to an act or omission that constitutes an—
- (a) offence for which the person has been convicted by a court; or
  - (b) infringement offence for which the person has been issued with an infringement notice and has paid an infringement fee.
- (5) The Board must not exercise any authority conferred by this section in respect of any offence committed by any person before the date of that person's registration or, as the case may be, the date on which that person's provisional licence was issued if at that date the Board was aware of that person's conviction for that offence.
- (6) If a person is registered under Part 10 in respect of more than 1 class of registration, the Board may exercise its powers under subsection (1)(a) to (e) in respect of each of those classes or 1 or more of those classes as the Board thinks fit.]

**<sup>ii</sup> Section 147ZA Appeals**

- (1) A person who is dissatisfied with the whole or any part of any of the following decisions, directions, or orders may appeal to the District Court against the decision, direction, or order:
- (e) any decision, direction, or order under any of sections 108, 109, 120, 133, 137, and 153 or Part 11 (except section 147C).

**Section 147ZB Time for lodging appeal**

*An appeal under section 147ZA must be brought within—*

- (a) 20 working days after notice of the decision, direction, or order was given to, or served on, the appellant; or*
- (b) any further time that the District Court may allow on application made before or after the expiration of that period.*
