Limited Certificate application for experienced electrical workers who are not yet registered but who wish to work in the industry.

This application form is for those applicants with experience but who need to complete examinations and practical assessments to receive electrical worker registration. Experience must have been assessed by the assessment team and an **offer** of a Limited Certificate (LC) issued by letter.

Guidance notes

What you need:

- › You must have previously applied for registration with evidence of your experience and this experience has been approved for registration. You must also have received an assessment letter advising of this and stating that you can apply for an LC.
- › You will need to be employed or about to be employed and have a nominated supervisor who has appropriate registration and a current practising licence.

■ **DO YOU MEET THE CRITERIA OF FIT AND PROPER PERSON?**

The Board must be satisfied that an applicant is a "Fit & Proper" person to be registered. If you are in doubt whether you are "Fit & Proper" then go to this [Policy Document](#) on our website.

If you think you might not meet the Board's criteria then please complete this form and submit it with the appropriate tick on the application form. A licensing officer will be in contact to discuss your circumstances. Note the Board has the discretion to register and licence a person who does not meet the criteria if they are able to show that they are a fit and proper person to hold registration.

■ **SAFETY TRAINING**

All applicants should do initial safety training at the beginning of their LC and this should be entered on the form if done previous to applying for your LC. However if not yet done you can do so after the LC is issued but within the following three months. If safety training is not completed within three months your Limited Certificate will be cancelled.

Please note that a straightforward Competence Programme is **NOT** sufficient for the safety training specified for an LC because it does not cover Safe Working Practices (SWP). If an augmented competence programme includes a SWP unit, for example a Site Safe Electrical Passport, then this will be acceptable. Check with your training provider that the course you are doing covers all four elements as advised in your assessment letter.

■ **COMPLETION OF REGISTRATION REQUIREMENTS**

If an LC is issued to you it will be issued for one year and within that period you are expected to do the appropriate training, exams, and practical assessments as stated in your assessment letter. If you do not make any attempt to complete these requirements a second LC is unlikely to be issued. In some cases an extended LC for 18 months may be issued to enable you to complete the necessary qualifications.

■ **PROOF OF IDENTITY**

The Board will require a certified copy of the personal identity page of your passport OR your driver's licence to confirm your identity.

■ **PAYMENT**

If you are a New Zealand Tax resident, payment of New Zealand's goods and services tax (GST) is mandatory. However, if you are not a New Zealand, you are exempt from this payment. The GST amount is 15% and applies to all fees. On the payment page, you should make a declaration as to whether or not you are a New Zealand tax resident.

Important notes

1. On the cover page of this application form is a date of issue. Please check you are using the latest application form before continuing as old applications forms will not be accepted. Check www.ewrb.govt.nz for the latest version of all forms.
2. You must complete all sections of this application form. Please read through the whole application form including the guidance notes before you start. This will give you a clear idea of what you need to provide.
3. Some of the information you provide will be displayed on the [Public Register of Electrical Workers](#). This will be your full name, your class of registration, whether or not you are licensed and any limitations that exist on your registration. The district in which you live will also be included.
4. A checklist is provided at the back of the application form. Work through the checklist to ensure that you have answered all questions and attached all necessary supporting documents. Complete the checklist before you submit your application for a licence.
5. When you have completed your application and your supervisor has counter signed please submit your application to the Board's postal address below.
6. Please do not email your application or courier it to the postal address as this may cause a delay in lodging your application.

LIMITED CERTIFICATE

Most Limited Certificates are issued with limitations, which include one or more of the following:

- limited to carrying out certain prescribed electrical work;
- working on approved premises;
- working for an approved employer;
- not being able to supervise non-registered persons;
- not being able to test and certify wiring installation work unless such testing and certification is done under supervision of a registered electrical inspector, or a registered electrician who is entitled to test and certify wiring installation work.
- being supervised by a supervisor of electrical work.

INFORMATION ABOUT SUPERVISORS AND EMPLOYERS

A supervisor of electrical work must be a registered person:

- whose registration allows them to carry out prescribed electrical work they are supervising;
- who is competent to carry out the prescribed electrical work they are supervising;
- who holds a current practising licence.
